

Teleki Scout Park - Overview

A. OWNERSHIP:

The Teleki Scout Park ("Park") is owned by the American Hungarian Friends of Scouting ("AHFS").

B. LIABILITY:

All activities, whether sponsored by the AHFS or not, are at the participant's own risk. The AHFS disclaims any and all liability for any claims and/ or injuries to: (1) any person(s) using the Park whether with the permission of the AHFS or not, or (2) to the property of any such person(s).

C. PURPOSE:

1. Provide an outdoor setting for scouting activities, including, but not limited to training, camping, and picnicking.
2. Provide camping and picnicking facilities for scouts and/or scout parents.
3. Provide camping and picnicking facilities for scouts who were previous members of but are no longer registered with the troops.

D. UPKEEP:

The Park is operated and maintained by the AHFS appointed Park Manager. The Park Manager supervises and ensures the proper and authorized use of its facilities.

E. USE:

The following are authorized to use the Park, provided they do so in a manner consistent with the purpose of the Park and abide by its Rules:

1. Registered members of the Cleveland Hungarian Scout Troops ("Troops").
2. Parents of scouts registered with the Troops.
3. Scouts who were previous members of but are no longer registered with the Troops.
4. Guests of authorized users are only permitted if the authorized user is also present. The authorized user assumes all responsibility for the conduct of their guests.

Other than for organized scouting events, if more individuals are participating than the authorized person's liability insurance coverage allows, event liability insurance must be obtained and verified by the Park Manager before using the Park.

All visitors to the Teleki Scout Park, except those participating in scout organized activities, need to obtain permission from the Park Manager and sign the Teleki Scout Park Waiver of Liability and the Teleki Scout Park Rules before entering the Park.

As noted in the Teleki Scout Park Waiver of Liability and agreed to by visitors, visitors use the Park voluntarily and at their own risk. AHFS is not responsible for any injuries that may be sustained by visitors nor anyone in their care, including children or guests.

Please see the Teleki Scout Park Rules. The AHFS reserves the right to change any of these Rules at any time and any rule changes will be posted on the AHFS website. Any situations not covered by the Rules will be up to management discretion to resolve. Visitors agree to comply with the Park Rules before visiting the Park.

The Park Rules are instituted for the safety and security of all visitors of the Park. Repeated violations of these Rules can result in the removal from the Teleki Scout Park of individual or individuals. Re-admittance to the Teleki Scout Park will be at the discretion of the Park Manager.
