

Teleki Scout Park - Waiver of Liability

In consideration of the right granted to access and use the Teleki Scout Park in Ashtabula County, Rome Township, Ohio (the "Park"), the undersigned (on his or her behalf and on behalf of all his/her minor children and invitees) hereby waives, releases and forever discharges the American Hungarian Friends of Scouting, its affiliates, managers, members, agents, attorneys, employees, staff, volunteers, heirs, executors, administrators, representatives, predecessors, successors and assigns from any claims or liability resulting from or relating to physical or personal injury, pain, suffering, illness, disfigurement, temporary or permanent disability, loss or death, and any property damage that may occur, whether caused by fire, theft, vandalism, water or land-related accidents, natural events or any other cause or mishaps during or with respect to the undersigned's use of or presence in the Park. The undersigned acknowledges that his/her use of the Park is entirely at the undersigned's own risk. The undersigned understands that injuries or other adverse consequences may arise as a result of the undersigned's own or others' negligence in the Park or as a result of conditions created by the undersigned or pre-existing in the Park. Nonetheless, the undersigned assumes all such risks, both known and unknown. The American Hungarian Friends of Scouting is not responsible for any condition existing at the Park or for errors, omissions, acts or failures to act of any party permitted to access and use the Park. The undersigned fully understands that this is a release of liability and agrees to voluntarily give up or waive any right that he or she otherwise may have to bring legal action against the American Hungarian Friends of Scouting, its affiliates, managers, members, agents and volunteers for any personal injury or property damage suffered by the undersigned as a result of or relating to his or her use of the Park, including, without limitation, for negligence on the part of American Hungarian Friends of Scouting, its affiliates, managers, members, agents and volunteers. This waiver and release of liability shall remain in effect from and after the date of the undersigned's use of the Park. The undersigned further agrees to indemnify, defend and hold harmless the American Hungarian Friends of Scouting, its affiliates, managers, members, agents and volunteers against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation (including reasonable attorney's fees and any related costs) or otherwise brought by the undersigned, his or her invitees, anyone claiming by or through the undersigned and any third parties as a result of, in connection with or relating to the undersigned's use of the Park.

Teleki Scout Park - Rules

1. The Park is only for the use of persons or groups who are authorized to do so by the AHFS. Overnight camping or other activities that are not organized scouting events have to be approved in advance by the Park Manager.
2. The troop leader gives permission for organized scouting events and coordinates dates, times and needs with the Park Manager.
3. All visitors and users of the Park for non scouting organized visits/events must obtain permission from Park Manager and sign a liability waiver and acknowledgement of the Park Rules before entering the Park.
4. The use of firearms or any form of pyrotechnic devices is strictly prohibited for non scouting organized visits/events.
5. Target shooting is permitted only at organized scouting events in the designated area and in compliance with safety rules.
6. Hunting is prohibited in the Park.
7. Swimming during a non scouting organized visit/event is only allowed with the permission of the Park Manager.
8. Swimming during organized scouting events is allowed with the permission of the troop leader and in compliance with safety rules.
9. There is no lifeguard on duty. All individuals swim at their own risk.
10. Diving in the lake is prohibited.
11. It is the responsibility of each visitor to the Park to maintain and ensure the safe, orderly and peaceful use of the Park. In the interest of minimizing damage to the facilities and expense to the AHFS, each visitor is also responsible for cleaning up after himself and to remind the other users of the facilities to do likewise.
12. No vehicles of any kind are permitted in any area of the Park other than its roadways and the parking lots, unless for official purpose as approved by the Park Manager or a Troop Leader. This applies to all vehicles including, but not limited to cars, pick-ups, ATV's, trail bikes and motorcycles.
13. Park speed limit is ten (10) miles per hour.
14. No fires may be set closer than twenty-five (25) feet of any building or other structure and in approved locations.
15. All fires must be supervised while burning and fully extinguished before leaving the Park.
16. All Park users must take their trash with them and leave no trace when using the Park.
17. Any non scouting organized visit/event or overnight camping of more than 7 users must include renting of a portable toilet at user's expense.
18. It is the responsibility of all Park users to stop any activity that is disturbing the beauty, quietness and cleanliness of the Park and to notify the Park Manager or troop leaders of any such activity.
19. The AHFS reserves the right to ban and/or prosecute persons who disregard these Rules.

I have read, understood and will comply with the **Rules of Teleki Scout Park**. I have also discussed this with all persons under age 18 in my party and they have authorized me to sign this agreement on their behalf. I assume all personal, financial and legal responsibility for the use of the Park.
